1. **Status of Measure T Projects**

[Building J] is in the close out phase. The entire building will be scheduled with classes for the fall semester. The new building (CTE) in Soledad is still at DSA awaiting their approval. It is speculated that we will get approval so that bidding can begin in Fall 2025.

Bldgs. F, G and H received approval for matching funds. Waiting for the form and letter to be released which should happen in late July. Until those are received the district cannot begin work. The funds should be approx. \$37M. The challenges that these buildings hold, not only their age, but the relocation of the sports programs during construction. Conversations with the Dean's and coaches are currently being conducted. When the projects start (approximately 2 years from now,) the Lot 3 parking area will be serving as the staging area for the contractors.

Merrill Hall: an FPP has been completed and submitted for matching funds on this project. Would know about this project about mid-way through F, G and H. It would be our last project. The funds for Series C (the last issuance of the bond funds) is \$27M and was secured this month.

Non-Measure T projects have been Maintenance roof replacement, the baseball and softball fields turf replacement and the resurfacing and striping of the parking lots.

2. **FINANCIALS**

The "Total Measure T Expenditures" as of 6/30/25 and the "Total Measure T Expenditures since inception were presented and reviewed. Total current expenditures are approximately \$110,565,425.83. A reminder that the month of June has not been finalized and closed out meaning some figures could change. Current expenditures for this fiscal year are for Building J, the Soledad CTE building, Practice Field. Minor expenditures for fixtures, furniture and equipment and final commissioning (HVAC systems) were expended for Bldgs. D, E K. None of the projects exceeded their budget.
